DIRECTIONS TO HERDING SITE

The herding site is approximately 80 miles northwest of the specialty headquarters, about two hours driving time unless during rush hour.
Turn left on Jamboree Road from hotel. At the 73 fwy. go north to the I-405 fwy. north towards Long Beach. Take the I-405 north to the 118 fwy. west. Exit from the 118 fwy. at Topanga Canyon Blvd. and turn left. Go approximately 1/4 mi. to Santa Susana Pass Road (traffic light) and turn right. Go 1 mile and at sign on left reading "Oak Valley Farms," turn into entrance.
From the herding hotel, which is about 15 to 20 minutes from herding site, go west on Ventura Blvd. to Topanga Canyon Blvd. Turn right, going north. Go approximately 7 miles to the traffic light at Santa Susana Pass Road and turn left. Go 1 mile and at sign on left reading "Oak Valley Farms," turn into entrance.
