### TERMS AND CONDITIONS: PLEASE READ CAREFULLY

By signing this Agreement, the applicant and co-applicant (if applicable) agree to pay the Membership fees above starting the first day of the month after the date of execution of this Agreement, and continuing until the next April 30 following the passage of at least twelve full months (regardless of the month joined). By way of illustration only, if a new member joins on July 1, 2009, the initial membership term would expire on April 30, 2011. This Agreement automatically renews for one-year periods on May 1 of each year after the initial membership term, unless and until the applicant(s) submits a written letter of resignation to the ACCC Board of Directors, PO Box 45, Arkansas City, prior to the automatic renewal date.

Each applicant is subject to the Bylaws of ACCC and Rules and Regulations promulgated by the Board of Directors. Accordingly, the terms of this Agreement may change, including annual dues and payment terms and conditions, by vote of the Board of Directors. By signing below, the applicant(s) agree to be bound by such future modifications to this Agreement. Further, applicant(s) have received and reviewed a copy of the Bylaws of ACCC, and agree to be bound by same.

Membership dues and other costs or assessments are payable upon receipt of the invoice for same, and shall be delinquent on or before the last business day of the billing month and thereafter accrue interest on the unpaid account at the rate of 1.5% per month until all overdue dues plus accrued interest are paid in full. If the account remains delinquent on the last business day of the following month, all Membership privileges shall be suspended. Should delinquent dues and accrued interest remain unpaid on April 30 (fiscal year-end), all Membership privileges shall permanently terminate for non-payment, but all membership dues shall continue to accrue through the end of the contract period, and interest shall continue to accrue on the unpaid account until the entire account, plus interest, is paid in full. If ACCC retains counsel to collect delinquent sums owed to ACCC, applicant and co-applicant (if applicable) agree to pay all ACCC costs and fees in collecting such delinquent sums, including, but not limited to, attorney fees, expert fees and all other expenses incurred by ACCC in collecting such sums.
