(b) Applicant must be attending or will attend a Catholic Elementary School in 2008 – 2009 school years.

(c) While applications may be submitted by more than one member of the same family, awards will be limited to one per family annually.

(d) **ALL APPLICATIONS MUST BE COMPLETE.** Incomplete applications will not be considered.
