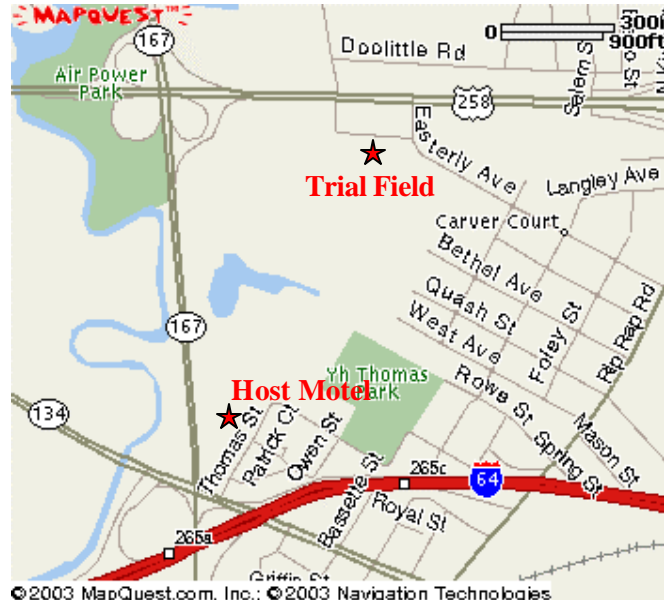

Take I-64 to exit 265C (Armistead Ave / Langley AFB). Go .18 miles, Turn Right on Rip Rap Rd. for .17 miles. Turn slightly right on Armistead Ave. and go about .39 miles. To reach the host motel, Super 8, turn right onto Thomas Street for approximately .10 miles. To reach the trial field, continue straight on Armistead Ave. to VA 134/ La Salle Ave and turn right. Go approximately .47 miles and merge onto 258N/Mercury Blvd W. and go .5 miles and turn right onto Easterly Ave, from Easterly Ave go .10 miles and the entrance to the field is on your right hand side.

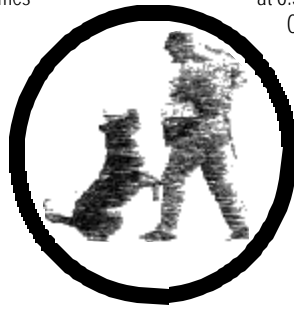


TRIAL INFORMATION
