Use the color card scoring system for State Championships for levels 2 & 3

Blue card flashed/blue ribbon given for 9.0 – 10.0

Red card flashed/red ribbon given for 8.0-8.9

White card flashed/white ribbon given for 7.0-7.9

Yellow card flashed/yellow ribbon given for 6.9 and below

All-Around will be determined by giving a value for each color ribbon (blue=4, red=3, white=2, yellow =1). Ribbons will be added together then divided by 4. The all-around ribbon color will be based on the following: blue = 3.5 and higher, red = 2.5 – 3.4, white = 1.5 – 2.4, yellow = 1.4 and below.
