Photographs

Printed Photographs: Determine the order you would like them in your show. Do **NOT** write on your photos. Use post-it notes, write the order number (001, 002, 003, etc) on the post-it and then affix to the back of the picture. (Writing on pictures can sometimes leave shadows or indentation marks during scanning.) Special items (birth certificates, travel brochure, etc.) you want scanned need to be numbered into the order as well.

Digital photographs: Place them on a CD-R and name them in the order you would like them in your show (001, 002, 003, etc). Telephone instructions are available if you need assistance creating a CD-R (fee-based). Special items (birth certificates, travel brochure, etc.) you want scanned need to be numbered into the order as well.

Event Order: I would like my photographs (print or digital) in order by event.

*Please place photographs in Ziploc type bags *by event*. Write the event name on the bag.

*Please title digital photos by event and number (*rehearsal001, rehearsal002, ceremony001, ceremony002*).
